September 2021 Hillcrest AT&T Mural Project



Request for Qualifications

The Hillcrest Business Association (HBA) is seeking qualified artists to apply for a competitive request for qualifications to create artwork that will be digitally printed and mounted on a wall at 6th Ave. and University Ave. It is intended that the artwork is not permanent but will remain on the facade of the building for several years.

The wall is at a critical intersection in Hillcrest, the gateway to the neighborhood. Thousands of commuters pass by this wall every day.

Artists should be prepared to submit final concepts within an expedited timeline. Artists are encouraged to submit multiple applications.

Selection Process

Step One:

• Interested Artists should submit their proposals as described below for committee review not later than 5pm on 9/24/2021.

Step Two:

- The committee will select an artist on or about 10/27/21. The Hillcrest Mural Sub-committee will act as a selection panel and guide the project during the selection process.
- Submissions will be ranked based on the following criteria: application completeness: creative use of space (how well the images complement the physical space); how effectively the work responds to the committee priorities of one or several of the following themes: LGBT community, diversity, peace and love, abstract, or nature/floral; professional ability; and quality of artwork.

- Proposals are welcomed by professionals and students. There are no geographical restrictions.
- No depiction of recognizable individuals, living or deceased, is allowed.
- The successful artist will sign a contract for the project.

Step Three:

- The selected artist will deliver final digital artwork no later than 5pm on 10/3/21 in a medium and size that can be digitally scanned, adjusted for size, magnified, or otherwise enhanced and printed on a to be determined final medium to be installed on a frame attached to the wall on the installation site.
- The selected artist will provide quality control comments to the digital printing company contracted by the HBA to ensure the final output is a true representation, with no degradation of resolution, quality, or appearance.
- Artist agrees to attend the unveiling event on 10/12/21 at 6pm. The artists will be hosted by the HBA and will participate in the event.

Artist fee

\$12,000 is budgeted for the creative components of this project paid in two portions. 50% on contract initiation and 50% on contract completion.

HBA and AT&T will fund the engineering, printing, transport, installation, site preparation, lighting, insurance and other costs for getting the artwork displayed at the location.

- Contact Information Include address, billing address, phone, and e-mail.
- Web Presence Include website and social media URLs.
- Artist proposal Provide a concept proposal for a mural in three parts in the following dimensions: 60'x 6', 17', 6" x 6', and 96'-2" x 6'.

- Images must be in PNG, TIF or JPG format; 1400 pixels x 1400 pixels minimum; 3000 pixels x 3000 pixels maximum; 72 dpi. File title should be "Artist First Initial_Artist Surname_Artwork Title," for example, J_Doe_Cityscape.jpg
- Resume Please provide a brief professional resume emphasizing art experience, public collections and public art commissions. Limit to 2 pages. Please submit as a PDF file as part of the application.
- Professional References Provide 3 professional references as a PDF file as part of the application.
- Images of Current Artwork Provide 3-5 examples of your artwork electronically. Include a list that provides image, title, type of media, dimensions, and year of completion. Do not mail or drop off original artwork.
- Artist Agreement a signed copy of the agreement below should be submitted as a PDF file as part of the application.

Application agreement:
